Rules and Conditions of entry:

1. The rules and conditions will be similar to those of the I.S.D.S.
2. Any dogs injuring a sheep will be disqualified and the handler shall pay for the damage.
3. Any objections shall be lodged with the Secretary in writing on the day of the trial together with a deposit of £5. The deposit will be refunded if the objection is found to be justified
4. The Organisers will not be responsible for any loss, damage or accident on the trial ground including injury to competitors, their dogs, cars or other property.
5. Any competitor failing to run on time may forfeit their run.
6. No competitor may approach the Judge during the progress of a trial.
7. Any handler entering trials and repeatedly not turning up will lose their automatic right to an entry form.
8. The committee reserves the right to refuse entries without giving a reason.
9. The committee reserves the right not to award any trophy if in their opinion a sufficiently high standard is not reached.
10. The committee's decision shall be final on all matters and their decision in respect of objections concerning a run will uphold that of the Judge.
11. Winning or being placed in a Starter Class does not remove the dog's Novice standing.
