

Sussex SDS Open Sheepdog Trials 2019

Entry fee: Members £5.00 per dog Non- members £7.00 per dog

Membership: £6.00

Entries are limited to 3 dogs per handler and will close when sufficient entries have been received. Please note, in the event of over-subscription handlers may be limited to 2 dogs.

Open National: 1st to 6th place.

Novice: A prize will be awarded for the best Novice dog.

Course: Full open driving course, shed and pen

There will be no refreshments available at these trials although the National Trust tearoom is a short walk from the Sheffield Park Trials.

Eligibility as a Novice

The dog must not have won two open novice trials, one open Maltese Cross class or two best novice awards at an open trial or have been placed up to and including 6th place in any open driving class.

Rules and conditions of entry

1. The rules and conditions will be similar to those of the International Sheep Dog Society
2. Any dogs injuring a sheep will be disqualified and the handler shall pay for the damage
3. Any objections shall be lodged with the Secretary in writing on the day of the trial together with a deposit of £5.00. The deposit will be returned if the objection is found to be justified.
4. The organisers will not be responsible for any loss, damage or accident on the trial ground including injury to competitors, their cars, dogs or property.
5. Any competitor failing to run on time may forgo their run.
6. No competitor shall approach the Judge during the progress of the trial
7. That any handler entering trials and repeatedly not turning up will lose their automatic right to an entry form.
8. The committee reserves the right to refuse entries without giving reason.
9. The committee reserves the right not to award any trophy if in their opinion a sufficiently high standard is not attained.
10. The committee's decision shall be final on all matters and their decision in respect of objections concerning a run will uphold that of the judge.
11. It is a condition of entry that you may be expected to let-out – this may require you to arrive some time before or remain sometime after your run.
12. The running order will be adhered to but may be altered by the Course Director to ensure the smooth running of the trial.
